- 3. 6830 NGC Disaster Fund Barbara suggested that we send that money now because it is needed. Also send the \$56.50 that was collected at the 9/5/2017 general WGC meeting to the Deep South Region Natural Disaster Fund to help restore gardens in Texas.
- 4. Hospitality: Carol C for Denise Friedlander, Hospitality Chairman, reported that the Dunkin Donuts Box of Joe was enjoyed by all especially the committee. The extra coffee was given to the VOW employees. Adjustment in the amount of coffee purchased will be made.
- 5. Grants: Tim Hadsell reported that he has submitted the Espoma Fertilizer grant and a grant from Holy Trinity for the Loaves & Fishes Gardens. Maria Wolfe is writing the NGC Plant America grant for the Community Garden at the Boys & Girls Club.
- 6. Youth Gardens: Tim reported that the vegetable garden at the Elks has now incorporated and is called Loaves & Fishes Garden. The plan is to become a 501(c)(3). Beginning Wednesday, October 18 from 2:30 4:00 and on Wednesdays thereafter, the garden is need of members' help to work with students in garden and in kitchen. The solar panels and fish
