Schedule Committee

GENERAL RULES

- 1. This show will comply in every respect with the requirements and objectives for an NGC Flower Show as established by National Garden Clubs, Inc. (NGC).
- 2. The 2017 edition of the National Garden Clubs, Inc. Handbook for Flower Shows (HB), with corrections and updates is the authority.
- 3. This Schedule is the Law of the Show.
- 4. All Divisions are open to all NGC, Inc. members and by invitation.
- 5. The Classification Chair or Chairs for each division will check exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility.
- 6. With the exception of Non-NGC Top Awards all judging of exhibits must be done by one or more panel(s) of NGC-approved judges. (See 2017 edition of the National Garden Clubs, Inc. Handbook for Flower Shows (HB) Chapter 1, pg. 4 for complete details.)
- 7. Judges' decisions are final. Awards may be withheld if not merited.
- 8. The National Garden Clubs, Inc. Standard System of Awarding (HB pgs. 5, 25) will be used in all Divisions.
- 9. Judges will be requested to provide written comments on all entries in Divisions II-V.
- 10. All blue ribbon-winning exhibits must be signed and dated by an NGC Accredited Judge on the judging panel. All non-blue ribbon exhibits scoring 90+ points must be so designated on the entry card and signed and dated by an NGC Accredited Judge on the judging panel. All other entry cards must be marked by an NGC Accredited Judge or Student Judge on the panel.
- 11. Dates/times for advance registration, accepting and removing exhibits and judging are stated on the inside front cover.
- 12. Registration is required for all exhibits. See individual Division Rules for entry procedures.
- 13. Ribbons, cards and exhibits may not be removed before 4:30 PM, Sunday, March 1, 2020.
- 14. Each exhibitor is limited to one entry per class, except in Division I Horticulture. See Division I Rules for additional information and clarification.
- 15. All entries must be the work of one exhibitor unless otherwise stated.
- 16. With the exception of Design and Botanical Arts divisions, all entries must include the binomial name or currently acceptable scientific designation. (HB Chapter 6, pg. 53). Emphasis is on fresh plant material. No artificial plant material is permitted.
- 17. Plants on threatened or endangered lists (virtualherbarium.org/EPAC) must have been grown by the exhibitor or obtained in a legal manner. Exhibition of invasive plants (fleppc.org) is not permitted.
- 18. The Flower Show Chairs will be available and on premises at all times during the show.
- 19. The Flower Show Chairs and the Classification Chairs for each division will be available during judging for possible consultations. They, along with the judges and clerks, are the only personnel allowed on the floor during judging.
- 20. Due care will be taken but neither the Wellington Garden Club, nor the Mall at Wellington Green will be responsible for damage to or loss of property.
- 21. All properties should be marked with exhibitor's name.
- 22. No cut fruits or vegetables are permitted.

AWARDS

The NGC Standard Award System, based on perfection, (100 points) is used in all divisions:

- a. Only one (1) First-Place (Blue) ribbon per class or subclass; must score 90 points or more.
- b. Only one (1) Second-Place (Red) ribbon per class or subclass; must score 85 points or more
- c. Only one (1) Third-Place (Yellow) ribbon per class or subclass; must score 80 points or more.
- d. One or More Honorable Mention (white) ribbons per class or subclass; must score 75 points or more. Award must be withheld if the exhibit does not meet the point value for the ribbon.

Top Division Awards

The following National Garden Club Top Awards, and non-NGC Top Awards will be awarded, if merited, to blue ribbon winners scoring 95 or above. See "Awards" Chapter 5 in the 2017 NGC Edition of Handbook for Flower Shows for all award requirements.

Final tabulations will be counted by the committee and the People's Choice Awards will be placed at 3 PM.

The following additional award may be given if merited:

DIVISION I - HORTICULTURE "HOW SMALL DOES YOUR GARDEN GROW?"

HORTICULTURE RULES

Horticulture classes are open to all Members of NGC, Inc. and by invitation.

- 1. All exhibits must be FRESH.
- 2. All exhibits must have been grown by the exhibitor.
- 3. Plant material must be in its natural state and may not be altered by application (treatment) of oil, commercial "shine" products, etc. that change the natural appearance. No wiring of specimens is permitted.
- 4. The rules for single species cut or container-grown are listed in the 2017 *Handbook for Flower Shows (HB)*, Chapter 6, Exhibiting in the Horticulture Division or supplement *Horticulture Exhibiting and Judging*.
- 5. In order to receive an NGC Top Exhibitor Award, the exhibitor must identify his/her entry by its binomial name or currently acceptable scientific designation. (HB Chapter 6, pgs. 53-54)
- 6. Advance registration with the Entry Chair is required. Deadline for all registration is February 14, 2020 Entry cards can be obtained from the Entries Co-Chairs Lisa Ferrano (561) 628-3675 paddockpark@bellsouth.net, Petra Russell (561) 398-5588 rede2enjoylife@gmail.com or Flower Show Co-Chairs Twig Morris, (561) 434-6629 twig_morris@hotmail.com and Carol Lazzarino (561) 312-2082 clazzar586@aol.com and are to be filled out in advance if possible. If written use waterproof ink, labels, or pencil. All specimens should be correctly labeled with their binomial name or currently acceptable scientific designation. Common names, enclosed in parentheses, may be included below the scientific designation.
- 7. Each section must contain a minimum of three (3) classes. Section F-H Classes limited to 4 entries per class.
- 8. Exhibitors may make more than one entry per class if each is of a different genus, species, variety, cultivar, type, form, size or color.
- 9. Size of container or specimen is limited, see specific dimensions listed in each section.
- 10. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower, but should be exhibited as foliage plants if they are grown for their leaves.
- 11. Specimens with a class designation in the schedule may not be entered in the "Any Other Worthy" class.
- 12. Only the Horticulture Classification Chair or Flower Show Chair can subdivide a class where there are three (3) or more exhibits of botanically identical (variety, cultivar, series or trademarked name), or similar in form, color, size or description to justify forming a subclass. (See HB Chapter 1, pg. 3 D 2.b.)
- 13. NGC Scales of Points for Horticulture exhibited in this show are on pg. 9 or see Chapter 14 in the 2017 Edition of *Handbook for Flower Shows* for all Scales of Points.

- 14. All Horticulture specimens must be of proper maturity to allow determination of Cultural Perfection.
- 15. Double potting is permitted if inner pot is not visible.
- 16. Container-grown plants should not appear to be recently reported, nor should they have obviously new top dressing.
- 17. All plant material must have been in the possession of the exhibitor for appropriate number of days listed in the chart below:

Type of Plant Material	Length of Possession

Annuals	90 days <i>Exception</i> : no minimum for early maturing seeds and/or transplants.

HORTICULTURE - SECTIONS AND CLASSES "HOW SMALL DOES YOUR GARDEN GROW?"

Only those plants with naturally small growth, or those designated as dwarf or miniature varieties or cultivars by nurseries and plant societies will be accepted in this division.

Division Eligible for Award of Horticulture Excellence

All entries will be displayed on tables skirted to the floor with black cloth as supplied by committee. All container grown plants must include proportionate matching or clear saucer.

SECTION A: "Perfection in the Parlor" Flowering Container-Grown Specimens

Eligible for Grower's Choice Award

Container size not to exceed 6" in diameter.

Class 20. Dish Gardens: Miniature landscape of three (3) or more specimens. Low dish. No saucer required. Reference HB pg 59, III

Class 21. Terrariums: Miniature landscape of three (3) or more specimens in a container with transparent sides. Top may be closed or open. Reference HB pg 59, III

Class 22. Planter: Three (3) or more specimens in a indoor or outdoor container. No saucer required. Reference HB pg 59, III

SECTION G: "Won't Track in the Dirt" - Epiphytic Plants (Grown without Soil)

Eligible for Grower's Choice Award

4 entries per class

Specimens mounted on wood, cork, or hanging basket not to exceed 10". Must provide Entries Chair with mounting requirements and dimensions no later than February 14, 2020.

Class 23. Bromeliads

Class 24. Orchids

Class 25. Tillandsia

Class 26. Any other worthy specimen

SECTION H: "Collectors' Corner" - Collections

Eligible for Collector's Showcase Award

4 entries per class

Allocated space 24" x 24"; total display height not to exceed 30 inches. A minimum of five (5) different species exhibited in individual numbered containers with corresponding numbers, plant relationship and current scientific designation listed on a 3"x 5" card for identification. Reference HB pg 60, IV.

- Class 27. No Dirt Collections: Epiphytic species (flowering or foliage). May use staging accessories i.e.: risers, mats, etc.
- Class 28. Flowering Collections: Flowering container-grown specimens. May use staging accessories i.e.: risers, mats, etc.
- Class 29. Foliage Collections: Foliage container-grown specimens. May use staging accessories i.e.: risers, mats, etc.

DIVISION II - DESIGN "HOUSES COME IN ALL SHAPES AND SIZES"

DESIGN RULES

- 1. The NGC Exhibit Policies are printed in the 2017 *Handbook for Flower Shows*, Chapter 7, Exhibiting in the Design Division, NGC Policies and Guidelines.
- Advance registration is required with the Design Entries Co-Chairs Caroline Kessman (561) 324-8320 ckessman@gmail.com or Jayne Kiesewetter email only: jbinwelly@comcast.net. Deadline date is February 3, 2020. Only four (4) entries per class. (See Show Timetable on inside cover page for complete details.)
- 3. Plant material and non-plant material permitted and not permitted in the Design Division are printed in the 2017 *Handbook for Flower Shows*, Chapter 7, pgs 80-81
- 4. All plant material used in the design must be identified on the white side of the 2.5"x 4" card, provided by the committee and included with the entry tag, also provided by committee.
- 5. The exhibitor is required to conform to the stated description and limitations of the Design Type if named in the class.
- 6. Only members of National Garden Clubs, Inc. may enter the Design Division by registering with Entries Co-Chairs Caroline Kessman (561) 324-8320 ckessman@gmail.com or Jayne Kiesewetter jbinwelly@comcast.net.
- 7. Rules for Design Types, Advanced Design Types, and Table Appointments are printed in the 2017 *Handbook for Flower Shows*. Chapter 7.
- 8. Underlays may not exceed depth or width of allocated design space.
- 9. Designers may change color of staging panel provided, but must conform to size and dimensions of original.
- 10. Petite designs will be exhibited 4' above the floor and viewed straight on from the front unless otherwise stated.
- 11. Written judges comments are requested on all non-blue ribbon awards.
- 12. Section B: No expensive flatware permitted in an NGC Flower Show.

A Creative 10" Reflective design. Freedom to use fresh and/or dried plant material. Staged on one quarter (1/4) of a 30" round pedestal, covered with black fabric. 11"Hx8"Dx8"W black staging panel with side panels provided by committee. May use underlay and change color of staging panel.

Class 2. "House of Cards" - Her Majesty's Throne 4 entries

8" Crescent Design interpreting the title. Freedom to use fresh and/or dried plant material. A 4-3/4"Hx2"Wx2"D black plastic "chair" container and 10"Hx9"Wx9"D white staging panel with side panels, provided by committee will be staged on top of a House of Cards. May use underlay and change color of staging panel.

Class 3. "Beach House" - Surfs Up or Hang Ten! 4 entries

5" Creative design interpreting the title. Freedom to use fresh and/or dried plant material. Staged inside a colorfully painted beach hut provided by committee. Viewing area 3-1/4"Wx7"H, interior depth 4"Dx4"W. Designer may use staging panel and underlay inside the beach house only. No embellishment of outside of Beach Houses permitted.

Class 4. "Up On the Roof" - Dining Out, Day or Night 4 entries

12" Exhibition Table interpreting the title. Freedom to use fresh and/or dried plant material, staged on top of the terra-cotta tiled roof of the "Adobe House" doll house. 13"Hx9"Wx9"D black staging panel with side panels provided by committee. May use underlay and change color of staging panel.

Class 5. "Jungle Habitat" - The Rain Forest 4 entries

9" Vignette Design. Freedom to use fresh and/or dried plant material. Staged within a three (3) sided hut with a thatched roof on backside and open bamboo rafters above the design space. 9"Hx9"Wx12"D black staging panel with side panels provided by committee. May use underlay and change color of staging panel.

- Only plants with naturally small growth, or those designated as dwarf or miniature varieties or cultivars by nurseries and plant societies will be accepted in this division, and must have been grown together for at least three (3) weeks (HB pg 88 D.5)
- 10. All exhibits must have been grown by the exhibitor or part of a family or club garden and in their possession for three (3) weeks. (HB pg. 88 D. 3)
- 11. Plant material must be in its natural state and may not be altered by application (treatment) of oil, commercial "shine" products, etc. that change the natural appearance. No wiring of specimens is permitted.
- 12. The rules for Container-Grown Miniature Gardens are listed in the 2017 *Handbook for Flower Shows (HB)*, Chapters 6 pg 59 III A. Chapter 10, pg 92 3b.
- 13. In order to receive an NGC top Exhibitor Award, the exhibitor must identify his/her entry by its binomial name or currently acceptable scientific designation. (HB Chapter 6, pgs. 53-54)
- 14. The standard Scale of Points are used to judge each youth exhibit.
- 15. Youth exhibits are judged by the NGC Standard System of Awarding.
- 16. A minimum score of ninety (90) is required to place an NGC Youth Top Exhibitor Award.
