- A. President's Report

If it goes to FFGC it will stay in the state of Florida and if to NGC it will go anywhere in the States. Jan will call Danese and find out where she has sent it. Carol Coleman seconded it. 3) WGC will be holding the Shredding Event on January 16, 2021 - budget isn't really a budget - no expenses and \$1000 income. Alison Albury stated it should be shown in the club budget. Discussion about whether in the budget should be amended to include fund raisers. 4) We also have a budget for the Plant Sale, see attached. Plant Sale scheduled for March 13, 2021. Maria Wolfe offered an alternate location at PNC Bank for the Shredding event.
